00.46.15 DANIEL-What can you tell us about it.

00.50.27 TEAL'C-The Goa'uld visit here regularly.

00.54.05 TEAL'C (OS CONT)-It is one of their favorite places to
harvest...

00.55.24 TEAL'C (CONT)-hosts for Goa'uld absorption.

00.57.26 DANIEL-You know, I wish you wouldn't say "harvest". We're
talking about human beings, not brussel sprouts.

01.03.20 TEAL'C (OS)-That is how the Goa'uld...

01.04.21 TEAL'C (CONT)-perceive it.

01.05.21 DANIEL-So the locals aren't used to friendly visitors.

01.07.13 O'NEILL-Well, that would answer why no welcome mat, I
suppose, huh?

01.11.05 CARTER (OS)-Colonel, this is weird. I mean, all...

01.12.16 CARTER (CONT)-the food here is fresh. There's even something
cooking on that fire.

01.17.06 DANIEL (OS)-But there's no one around.

01.21.23 O'NEILL (OS)-Well,...

01.23.12 O'NEILL (CONT)-keep your heads up.

01.55.11 O'NEILL-Hasn't been deserted long.

02.13.20 HANNO (OS)-Ak-na!

02.20.16 CARTER (OS)-Colonel.

02.21.10 O'NEILL-Hold your fire.

02.23.11 DANIEL-They probably think we're Goa'ulds.

02.24.27 O'NEILL (OS)-Daniel,...

02.26.00 O'NEILL (CONT)-think you could find a language that could
communicate to these people that we're human like they
are and that we're friendly.

02.34.10 HANNO-Why should I believe you? That is a weapon.

02.38.04 O'NEILL-So is that. Tell you what -- I'll go first.

03.23.22 HANNO-Jaffa!

03.25.09 O'NEILL-Hold it! Jaffa, yes -- but he's a good guy.

03.32.09 CARTER-You don't know him. He's peaceful.

03.34.18 CARTER (OS CONT)-Tell him you're peaceful, Teal'c.

03.36.20 TEAL'C-It is true.

03.37.10 HANNO-He lies. I know him.

03.39.16 O'NEILL-How?

03.41.00 HANNO-This Jaffa killed my father.

04.52.18 O'NEILL (OS)-Teal'c,...

04.54.11 O'NEILL (CONT)-you ever seen this kid before?

04.56.16 TEAL'C-I have not.

04.58.03 HANNO-He's a coward. He lies.

04.59.24 MILITIAMAN (OS)-Hanno!

05.00.22 MILITIAMAN (CONT)-The mandates.

05.03.08 HANNO-He is not Byrsa. The mandates do not apply.

05.07.04 MILITIAMAN (OS)-And what if you are mistaken?

05.09.10 MILITIAMAN (CONT)-I do not recognize...

05.10.01 MILITIAMAN (OS CONT)-this Jaffa.

05.12.17 HANNO-He is the one. He killed my father.

05.14.28 MILITIAMAN-If you are right, he will be put through cor-ai.
But we do not take revenge like this. Or we are no
better than the Jaffa.

05.29.24 HANNO-Cor-ai will sustain my belief.

05.32.12 DANIEL-Cor-ai?

05.33.05 HANNO (OS)-But first...

05.33.20 HANNO (CONT)-you meet the elders. Come.

05.41.28 O'NEILL-I always wanted to meet the elders.

06.00.27 DANIEL (OS)-That's interesting. I wonder if everyone's
coming...

06.02.10 DANIEL (CONT)-from some religious event.

06.04.28 O'NEILL-Why does it always have to be some religious thing
with you? Maybe their coming from a swap meet.

06.10.24 HANNO-When the gods come through the circ kakona, we scatter
in many directions to hide from those...

06.16.01 HANNO (OS CONT)-who would hurt us.

06.18.22 HANNO (CONT)-They're overdue to visit us again.

06.24.22 DANIEL (OS)-Circ.

06.25.26 DANIEL (CONT)-That's a Latin derivation, circle. But kakona,
that's Greek.

06.28.18 DANIEL (OS CONT)-That's weird. -- two root languages in one
culture.

06.31.19 CARTER-What does it mean.

06.33.10 DANIEL-Uh, circ-kakona... circle of woes. Their name for the
stargate?

06.41.06 CARTER-I don't like this.

06.52.28 ELDER WOMAN-You may approach.
07.06.03 You are the leader, yes?

07.08.03 O'NEILL-Yes.

07.09.13 ELDER WOMAN-You may go.

07.11.07 O'NEILL-Just like that?

07.12.24 DANIEL (OS)-Wait, we'd like to stay a little while...
07.14.12 DANIEL (CONT)-and, and learn from you. Possibly you can
learn from us. I mean, you seem to need help avoiding
the Goa'uld --

07.17.29 ELDER WOMAN (OS OVERLAPPING)-You may go.
07.19.26 ELDER WOMAN (CONT)-Now.

07.23.09 O'NEILL-Daniel, it's important that we respect our elders.
Teal'c, dial it up.

07.29.15 ELDER WOMAN-Not him.

07.33.04 O'NEILL-Excuse me?

07.34.27 HANNO-For him there will be cor-ai.

07.36.21 O'NEILL-Alright, let me bottom line it for you, okay. You
can't have that man.

07.39.25 HANNO-He is not a man. He's Jaffa.

07.41.13 O'NEILL-He's already told ya, he doesn't know who you are.

07.48.12 HANNO-You say you don't remember me?

07.50.15 TEAL'C-I do not.

07.51.14 HANNO-Then do you remember this?

08.05.22 APOPHIS-Do it!

08.24.18 HANNO-You remember me now, do you not?

08.27.11 O'NEILL (OS)-Don't say...

08.27.22 O'NEILL (CONT)-a word, Teal'c.

08.28.24 TEAL'C-But I must.

08.29.13 O'NEILL-That's an order. Don't say anything.

08.33.28 HANNO-He does not need to say anything. Take him in custody.

08.37.20 O'NEILL-Hold it!

08.38.16 DANIEL (OS)-Jack, that's not the way to handle this.

09.15.15 O'NEILL-I don't suppose we could get him out on bail?

09.20.04 HANNO-He is guilty. He must pay for what he has done.

09.24.02 O'NEILL-And you've already decided this.

09.27.16 HANNO-Yes.

09.24.13 O'NEILL-Hey -- at least untie his hands. C'mon.

09.35.25 HANNO (OS)-Tomorrow we will have the cor-ai.

09.38.00 HANNO (CONT)-You are welcome to stay.

09.41.26 O'NEILL-Gee, thanks.

09.48.15 Alright, when they come back, Daniel, you draw 'em in.
Carter and I'll take right and left flanks.

09.54.09 DANIEL-Whoa,...

09.54.20 DANIEL (CONT)-wait a minute, are you talking break out?

09.57.15 O'NEILL-Uh, yah!

10.00.07 O'NEILL (OS CONT)-We're gonna grab Teal'c...

10.01.01 O'NEILL (CONT) -and head straight for the stargate. It'd be nice if we could do it without bloodshed.

10.04.29 TEAL'C-No.

10.08.03 O'NEILL-Excuse me?

10.08.29 TEAL'C-Do not attempt your plan. I will not go.

10.14.25 O'NEILL (OS) -Y'know, that's a really odd sound.

10.17.28 O'NEILL (CONT) -I thought you just said you wouldn't go.

10.20.05 TEAL'C-That is correct.

10.21.07 O'NEILL-Why?

10.21.28 TEAL'C-Because to go would disrespect the Byrsa.

10.24.12 O'NEILL-Disrespect?

10.25.15 DANIEL (OS) -Teal'c is right. We...

10.26.05 DANIEL (CONT) -should show some respect.

10.28.13 O'NEILL-Did anyone else hear that kid say Teal'c was guilty already? For all we know they want to kill him.

10.34.25 DANIEL (OS) -W-w-wait, who said anything about killing?

10.36.16 DANIEL (CONT)-I mean, all they said was they want to put him
through cor-ai. Near as I can figure, that is like a
simple trial.

10.41.00 O'NEILL-Now see, it's that "near-as-I-can figure" part that's
got me a little worried.

10.45.12 O'NEILL (OS CONT)-What if their idea of a...

10.46.07 O'NEILL (CONT)-simple trial is a simple beheading?

10.49.12 TEAL'C (OS)-I will not...

10.49.25 TEAL'C (CONT)-run.

11.11.29 O'NEILL-Excuse me. What're you doin'?

11.16.00 BYRSA WOMAN-I am the Jaffa's voice for the cor-ai.

11.21.22 O'NEILL-Well, I think his voice is just fine.

11.23.28 DANIEL (OS)-I think she means...

11.24.23 DANIEL (CONT)-kinda like his defense attorney.

11.26.12 BYRSA WOMAN (OS)-I have...

11.26.27 BYRSA WOMAN (CONT)-been chosen. I must witness his pecca-
ve'.

11.31.10 CARTER-What's a pecca-ve'?

11.32.25 DANIEL (OS)-There's a Latin word that's...

11.33.20 DANIEL (CONT)-similar. It basically means "I have sinned."

11.36.14 CARTER-She wants his confession?

11.39.11 O'NEILL-Has it occurred to anyone that he might not be
guilty?

11.42.28 BYRSA WOMAN-If he were not guilty there would be no cor-ai.

11.55.05 O'NEILL-Innocent until proven guilty. Heard of it?

12.01.13 DANIEL-Actually, throughout history the idea is pretty rare.

12.03.07 DANIEL (OS CONT)-Most cultures assume things the other way
around.

12.06.26 DANIEL (CONT)-I'm just saying.

12.12.16 BYRSA WOMAN-I must hear the Jaffa's pecca-ve'.

12.15.11 O'NEILL-Well, you're outta luck, 'cause you're not gonna get
him to pecca anything.

12.18.23 BYRSA WOMAN-Who will be his voice.

12.23.03 O'NEILL-That would be me.

12.27.29 CARTER-Uh, you?

12.29.24 BYRSA WOMAN (OS)-You will be his voice for the cor-ai?

12.32.10 O'NEILL-Yep.

12.35.18 BYRSA WOMAN-As you wish. I will tell the elders.

12.48.27 DANIEL-You sure you're up to this?

12.51.22 O'NEILL-Why? You don't think I am?

12.54.06 DANIEL-Well, it's, it's just that I've never actually heard
you referred to as a diplomat. I think, um,
antagonist...

19.58.23 DANIEL (OS CONT)-was the word used.

13.00.00 O'NEILL (OS)-But I'm his...

13.00.19 O'NEILL (CONT)-Commanding Officer. It comes with the
territory.

13.02.26 CARTER-Wouldn't Daniel be better at it?

13.04.12 CARTER (OS CONT)-I mean, being a, a linguist and a cultural
expert.

13.08.20 CARTER (CONT)-Sir.

13.11.02 O'NEILL-Alright, we'll all do it. How's that?

13.16.25 DANIEL-That's fine.

13.18.20 CARTER-Co-co-counsels. Works for me.

14.16.19 HANNO-I am sorry.

14.20.03 TEAL'C-You are sorry?

14.22.10 HANNO-When I first saw you, I let my anger control me and I
threatened your life.

14.28.22 HANNO (OS CONT)-This is contrary...

4.29.15 HANNO (CONT)-to Byrsa mandates, and by doing it I shamed
myself and my whole clan. I ask your forgiveness.

14.38.23 TEAL'C-You have it.

14.44.23 O'NEILL-This is startin' off better than I thought it would.

14.53.13 HANNO (OS)-Jaffa,...

14.55.13 HANNO (CONT)-you killed my father. For this crime the
punishment is death. I will now lead the cor-ai.

15.03.17 O'NEILL (OS)-Objection!

15.06.10 MALE VOICE (OS)-Objection?

15.10-.16 O'NEILL-That's something we say back on Earth when... never
mind. You can't be the judge. That's not fair.

15.21.24 HANNO-Judge?

15.22.23 O'NEILL-Yeah, the guy who controls the proceedings, decides
what happens here.

15.26.11 HANNO-Why is it not fair?

15.27.25 O'NEILL-Because you're the son of the victim.

15.29.14 HANNO-Yes.

15.32.05 O'NEILL-Well, the judge has to be impartial.

15.32.28 HANNO-What does that mean?

15.37.23 DANIEL-Uh, impartiality would require someone who hasn't
already formed an opinion about Teal'c's guilt...

15.42.13 DANIEL (OS CONT)-or innocence.

15.44.01 HANNO-How could there be such a person? Anyone who has a
mind, has an opinion.

15.49.14 O'NEILL-Your honors, I respectfully request that someone else
be in control of this... what is it --?

15.56.09 DANIEL-Cor-ai.

15.57.18 O'NEILL-Cor-ai.

16.03.08 ELDER WOMAN-Only the person who has suffered...

16.05.10 ELDER WOMAN (OS CONT)-understands the pain which has been
inflicted.

16.09.27 ELDER WOMAN (CONT)-Who else can fairly say what the
punishment must be.

16.15.06 O'NEILL-Well, you could, for one.

16.20.13 ELDER WOMAN-Hanna will continue.

16.24.05 O'NEILL-Unbelievable.

16.25.01 DANIEL-It's actually rather Talmudic -- only he who is
wronged can forgive --

16.27.21 O'NEILL (OVERLAPPING)-Will you can it.

16.40.00 HANNO-You remember me?

16.42.20 TEAL'C-I do.

16.46.10 HANNO-And you are the one who killed my father, are you...

16.48.28 HANNO (OS CONT)-not?

16.49.04 O'NEILL (OVERLAPPING)-Don't answer that, Teal'c.

16.54.22 TEAL'C-Yes. I am the one who killed your father.

17.23.18 O'NEILL (VO)-Teal'c, are you trying to commit suicide?

17.27.09 TEAL'C-I do not understand.

17.28.22 O'NEILL-Why didn't you tell me you were guilty? At least
before you told a room full of people that want to see
you dead.

17.35.19 TEAL'C-You already knew. Only you did not want to hear it.
That is why you asked me not to speak.

17.52.02 O'NEILL-What happened?

17.53.19 TEAL'C-Apophis ordered me to kill Hanno's father.

17.59.26 O'NEILL-Hey, can you guys guard from outside? We're not
goin' anywhere. So you were following orders.

18.12.10 TEAL'C-Hanno's father died by my hand. No one else's. I am responsible.

18.20.21 TEAL'C (OS CONT)-What I did while serving...

18.21.28 TEAL'C (CONT)-Apophis, I will not hide from.

18.24.21 O'NEILL-Even if the punishment is death?

18.26.12 TEAL'C-Then that is what I deserve.

18.28.07 O'NEILL-Teal'c, you sound like you wanna die.

18.30.07 TEAL'C (OS)-Colonel O'Neill,...

18.31.08 TEAL'C (CONT)-have you ever faced the crying eyes of a child whose father you have just murdered?

18.39.08 O'NEILL-Not exactly.

18.44.25 O'NEILL (OS CONT)-Teal'c, there are a lot of things we do that we wish we could change, and we sure as hell can't forget.

18.55.05 O'NEILL (CONT)-But the whole idea of chain of command undermines the idea of free will. So, as soldiers, we have to do some pretty awful stuff.

19.07.15 O'NEILL (OS CONT)-But we're following orders like we were trained to.

19.10.17 O'NEILL (CONT)-It doesn't make it easier -- it certainly doesn't make it right -- but it does put some of the responsibility on the guy givin' those orders.

19.18.01 TEAL'C-Then you are saying Apophis is responsible for Hanno's father's death.

19.21.03 O'NEILL-Yes!

19.21.20 TEAL'C-You are wrong, O'Neill.

19.24.20 TEAL'C (OS CONT)-While in the...

19.25.04 TEAL'C (CONT)-service of Apophis I did many things. For these deeds my victims deserve retribution.

19.32.24 O'NEILL-Can we focus on this one case only for now, please?

19.36.05 TEAL'C-This one case represents the many.

19.37.25 O'NEILL-Well, it shouldn't.

19.46.18 Why? Why are you doin' this?

19.52.14 TEAL'C-When I look into Hanno's eyes, I se the horror on the faces of many others as they watch their loved ones prepare for Goa'uld absorption. Worse yet is the face of the victims whom I selected as they realize they are about to take their final human breath.

20.09.23 TEAL'C (OS CONT) -Hanno's father is not the first nor the last
of those whose lives

20.12.14 TEAL'C (CONT) -I've taken. And I have done far worse,
O'Neill. I cannot give all of their loved ones
retribution. But I can, at least, give it to this one.
I am sorry, O'Neill. I will not run.

20.34.00 O'NEILL-Well, I'm sorry, Teal'c, but that's unacceptable.

20.38.05 O'NEILL (OS CONT) -I'm gonna do what I have to do to keep you
alive whether you like it or not.

20.53.28 O'NEILL-What's the plan of attack.

20.55.14 DANIEL-Well, the way I look at it, Teal'c has already pled
guilty. So, to draw a parallel to an American trial, we
have to look at this sort of like the sentencing phase.
We need to prove to these people that he doesn't deserve
to die.

20.08.21 CARTER-How do we do that?

20.10.25 DANIEL-We need to convince them that he's a different man now
than he was then.

21.13.22 O'NEILL-Good luck.

21.28.20 O'NEILL-Tell us what happened to your wife.

21.32.26 DANIEL-He name is Sha're. She was captured by Apophis'
Serpent Guards and changed.

21.39.25 O'NEILL-She's now a Goa'uld?

21.41.03 DANIEL-Inhabited by one, yes.

21.43.21 O'NEILL (OS)-And how did she get to be...

21.44.23 O'NEILL (CONT)-one of the victims?

21.46.00 DANIEL (OS)-The leader of the Serpent Guards picked her out
of a crowd of other women -- at random, really.

21.50.01 O'NEILL-Who was the Serpent Guard?

21.52.07 DANIEL-Teal'c.

21.59.07 The old Teal'c. At that time he hadn't joined us yet.
He didn't know me or that Sha're was my wife.

22.05.25 O'NEILL-But the fact is that you now work side by side with
the man responsible for your wife's fate.

22.12.20 DANIEL-It was difficult for me at first. I wanted to hate him. But now I know that it was a different Teal'c that chose Sha're -- and I know that if there were any way for him to help me get my wife back, this Teal'c would do it gladly.

22.27.08 DANIEL (OS CONT)-Even if it meant giving up his own life.

22.32.03 DANIEL (CONT)-This Teal'c is my friend.

22.37.09 TEAL'C (OS)-There were fifty human captives.

22.40.04 TEAL'C (CONT)-All were unarmed. Apophis ordered me to slaughter them all.

22.46.02 CARTER-But you didn't, did you?

22.47.20 TEAL'C-I did not.

22.49.07 CARTER-What did you do?

22.53.20 TEAL'C-I turned my weapon on my fellow Serpent Guards.

22.57.03 CARTER-It was a huge risk for you, wasn't it Teal'c?

22.59.02 TEAL'C-I made a decision.

23.00.13 CARTER-I think you're being a little modest here. You have a family.

23.04.05 CARTER (OS CONT) -Do you think you'll ever see them again?

23.12.06 TEAL'C-It is unlikely.

23.29.14 BYRSA WOMAN-Have you lost your way?

23.31.11 DANIEL-Oh, no, I'm, I'm just looking around, if that's okay.

23.36.03 BYRSA WOMAN-You are welcome to do so.

23.38.13 DANIEL-You have a very lovely existence.

23.41.14 BYRSA WOMAN-Thank you. It would be made lovelier were it not
for the Goa'ulds -- and the Jaffa.

23.49.00 DANIEL-The one thing I, I can't seem to figure out is, is, is
where you live.

23.53.27 BYRSA WOMAN-We live here.

23.56.07 DANIEL-Oh, no, no, where you sleep... at night -- where you
take shelter. Where do you sleep?

24.00.21 BYRSA WOMAN-Uh, we sleep in the hiding.

24.03.03 DANIEL-The hiding?

24.05.03 BYRSA WOMAN-We have hidden caves and tunnels in all directions.

24.09.08 BYRSA WOMAN (OS CONT)-When the evil ones come in...

24.10.19 BYRSA WOMAN (CONT)-through the Circ Kakona, we flee in all directions and we disappear.

24.16.16 DANIEL-So they catch only the slowest among you.

24.19.04 BYRSA WOMAN-Oh, no, we would never leave anyone behind. We all go, or none of us do.

24.30.27 DANIEL (OS)-I think I have something that might help us out.

24.33.22 DANIEL (CONT)-Teal'c,...

24.35.20 DANIEL (OS CONT)-tell us exactly what happened that day.

24.39.14 TEAL'C-Apophis ordered me to kill one of the villagers so the rest would obey.

24.33.12 DANIEL-Okay, well, I think we've all heard the Reader's Digest version of the story, but -- there's more to it, isn't there?

24.48.20 DANIEL (OS CONT)-Like why you chose Hanno's father.

24.52.26 TEAL'C-We brought those we had captured back to the hall. Apophis ordered the selection process to begin.

25.08.04 APOPHIS (OS DISTORTED)-Teal'c.

25.13.18 APOPHIS (CONT DISTORTED) -Kill one of them.

25.24.20 I said kill one of them.

25.26.27 APOPHIS (OS CONT DISTORTED) -If you hesitate...

25.28.16 APOPHIS (CONT DISTORTED) -I will kill them all.

25.43.23 Do it!

26.09.25 TEAL'C (VO) -Apophis chose seven women and let the rest go.

26.15.06 DANIEL -The truth is our defense.

26.17.10 CARTER -I think I see where you're going with this, Daniel.
This is good. This could make the difference in the
cor-ai.

26.21.19 O'NEILL -It's a kangaroo court. Nothing's gonna make a
difference. Isn't that painfully obvious to anybody?
That kid made up his mind before we even got here.

26.31.10 DANIEL -So what do you suggest?

26.34.07 O'NEILL -Carter and I are going back to Earth for
reinforcements.

26.36.27 DANIEL -What, you're gonna shoot his way out?

26.38.17 O'NEILL (OS) -No, Daniel. I'm hoping we can bring back enough
fire power...

26.43.10 O'NEILL (CONT)-so it'll scare 'em into turning Teal'c over.
That's how I'd like to see it go down.

26.46.27 TEAL'C (OS)-I have...

26.47.02 TEAL'C (CONT)-already told you, O'Neill, I will not run.

26.49.09 O'NEILL-Teal'c, you're goin' back with us if I have to knock
you out and carry you myself. Got it?

26.55.05 O'NEILL (OS CONT)-Buy as much time as you can, Daniel.

27.02.17 GENERAL HAMMOND-Colonel, where are Teal'c and Daniel?

27.04.19 O'NEILL (OS)-We'll explain, sir.

27.06.09 O'NEILL (CONT)-But first I need you to mobilize a combat unit
ready to go back to that planet ASAP.

27.10.28 GENERAL HAMMOND-Do it. Now how about filling me in.

27.19.01 DANIEL (OS)-So,...

27,19,18 DANIEL (CONT)-by killing that man you actually saved the
lives of the rest of the villagers. You even saved
Hanno's life.

27.26.04 TEAL'C-It is true.

27.27.04 DANIEL-But can you be sure Apophis would have really killed the rest of the villagers.

27.32.04 TEAL'C-I have seen him do it many times.

27.34.22 DANIEL (OS)-So...

27.34.29 DANIEL (CONT)-although you were faced with a terrible decision, you chose the lesser of two evils.

27.40.06 HANNO-He chose to kill a crippled man.

27.43.23 HANNO (OS CONT)-The man least able to run away. The most helpless of us all.

27.46.11 HANNO (CONT)-His choice was not moral. It was cowardly and evil.

27.49.28 DANIEL-Hanno, I'm told that the Byrsa's only defense against the Goa'ulds is their ability to run and hide. Is that right?

27.59.10 HANNO-We have escape tunnels and caves. When the lights on the Circ Kakona appear, we can disappear before the Goa'uld arrive.

28.08.15 DANIEL-But you have to move fast, right?

28.11.08 HANNO-Of course.

28.16.02 DANIEL-Teal'c, did you know that back then?

28.18.04 TEAL'C-I did. It was often very difficult to locate the villagers. They seemed to be able to vanish into the forest as quickly as a flock of birds.

28.35.06 DANIEL-How fast could your father move with only one leg?

the Goa'ulds and the Jaffa. Therefor I ask that you
spare his life.

29.44.16 HANNO-You have defended this Jaffa repeatedly by saying he is
a changed man. And for proof you have given many
examples of his firing upon his former comrades.

29.52.25 DANIEL (OS)-Yes.

29.53.08 HANNO-Then why did he not fire upon them here instead of
killing my father?

29.56.05 DANIEL-Because it wouldn't have done any good.

29.57.13 HANNO-My father might be alive today.

29.59.05 DANIEL-No! Not necessarily. Even if Teal'c had succeeded that day, the Goa'uld would have sent more Jaffa to exterminate everyone -- your, your entire population.

30.07.21 HANNO (OS)-How do you know that?

30.08.23 HANNO (CONT)-They did not do that to your people.

30.10.04 DANIEL-They tried. We have defenses that you don't. Teal'c may have killed Hanno's father, but in doing so he saved you... and you... and all of you.

30.25.22 FEMALE VOICE-This is a lie.

30.36.17 DANIEL (OS)-Teal'c's death...

30.27.12 DANIEL (CONT)-will not change the past but his continued life can help all of our future. Can you really justify killing him now?

30.28.12 ELDER WOMAN-His fate is not to be decided by us. Cor-ai mandates that only Hanno can make that decision.

30.47.13 MALE VOICE-The mandates!

30.53.12 HANNO-Your argument is wise, and moving. I commend you.

30.58.17 DANIEL-Thank you.

31.02.27 HANNO-You have made a compelling argument that this Jaffa's more recent and continuing good should somehow negate his past evil. I have but one final question. Can his recent actions, or any future actions, return my father from the dead?
