05.24.27 THOR- Yes.

05.26.05 O'NEILL (OS)- You know,... O'NEILL (CONT)- ... we have satellites, telescopes, that can see things like spaceships.

05.30.10 THOR- Our ships have never been detected in orbit... THOR (OS CONT)- ... around Earth before.

05.35.09 O'NEILL- Oh. All right. I'm sorry. You were saying something... O'NEILL (OS CONT)- Matter of great importance? 05.45.07 THOR- We received word of what transpired with your people and the Goa'uld named Hathor.

05.49.22 O'NEILL- She had it coming.

05.50.24 THOR (OS)- As a result,...

THOR (CONT)- ... the Goa'uld System Lords have turned their attention towards you.

05.55.14 O'NEILL- What, for killing Hathor? They should be thanking us. She was planning to overthrow them, you know.

06.02.06 THOR (OS)- Her intentions are irrelevant. THOR (CONT)- Earth has once again proven it can be a formidable threat ... THOR (OS CONT)- ... to the Goa'uld.

06.07.09 O'NEILL- Oh, now we're a threat to them?

06.10.00 THOR- They have decided it is a concern to be dealt with.

THOR (OS CONT)- The System Lords are capable of launching an assault one hundred times more powerful...

THOR (CONT)- ... than that which you previously withstood at the hands of Apophis.

06.22.04 O'NEILL- Okay. Um, that could be a problem.

06.25.14 THOR (OS)- The Asgard agree.

THOR (CONT)- I have come to offer our assistance.

06.30.13 O'NEILL- Now, see, that would be appreciated. I've seen your work, it's great.

06.34.20 THOR- The vast majority of the Asgard fleet is currently unavailable.

06.40.14 O'NEILL- Oh. Uh, so what'd you have in mind?

06.45.02 THOR (OS)- With your permission,...

THOR (CONT)- ..the Asgard will attempt to negotiate with the Goa'uld System Lords to include Earth in the Protected Planets Treaty.

06.56.00 O'NEILL- That's a good thing, right?

06.57.26 THOR- It would prevent this attack.

07.01.26 O'NEILL- Good. Uh, to be honest with you, I'd rather have a fleet of your ships here. A few of these babies, and we could just... (beat) We could try the negotiating thing.

07.17.25 THOR (OS)- I will contact the System Lords. THOR (CONT)- You may return to your planet now.

07.29.25 O'NEILL- Excuse me? I assume someone's gonna show me the way back? Thank you!

07.44.26 HAMMOND- Why would the Goa'uld agree to this negotiation?

- 07.48.07 TEAL'C- The Goa'uld fear the Asgard.
- 07.50.09 DANIEL- Plus I assume the Asgard would offer the Goa'uld something in return. I mean, that's generally the way negotiations work.
- 07.55.01 HAMMOND- Well, what if the summit fails?

07.57.22 O'NEILL- Well, Thor said that's pretty much the only option he could offer. If it fails... total annihilation.

08.05.15 HAMMOND- Well, the President is wondering how confident we are... HAMMOND (OS CONT)- ... in trusting the Asgard.

08.10.21 CARTER- The Tok'ra trust them.

- 08.12.12 DANIEL (OS)- They helped Jack out... DANIEL (CONT)- ... when he got the Ancient's language downloaded into his brain.
- 08.16.04 O'NEILL- You gotta love 'em for that.

08.17.28 HAMMOND (OS)- But we know very little...

HAMMOND (CONT)- ... about the politics out there. How do we know the Asgard truly have our best interests at heart.

08.24.00 O'NEILL- Well, I suppose we don't. But if they have any other agenda in mind -

08.32.16 HAMMOND- Colonel, do we need Security?

O'NEILL- No. I'll vouch for him, sir. (beat) Major Samantha Carter. Doctor Daniel...
O'NEILL (OS CONT)- ...Jackson... You remember Thor.
O'NEILL (CONT)- Uh, Thor...This is Teal'c...
O'NEILL (OS CONT)- ...and Major General George Hammond. He's the...
O'NEILL (CONT)- ...leader of our facility here.

08.58.10 THOR- The System Lords have agreed to negotiate.

09.02.05 O'NEILL- That's good news.

09.03.07 THOR- They will arrive in four days.

09.06.04 O'NEILL- Here?

09.06.28 THOR- It is customary for such negotiations...

THOR (OS CONT)- ... to take place on the planet in question.THOR (CONT)- Three representatives from the System Lords will arrive by Stargate. You must be prepared to speak on behalf of all the inhabitants of Earth.

- 09.20.00 O'NEILL- Uh, weil... Maybe not me, personally...
- 09.23.13 THOR- We have chosen you, O'Neill, to represent your planet at the proceedings.

O'NEILL- All right, see, now that could be a mistake. Um... You see, Doctor...
 O'NEILL (OS CONT)- ... Jackson here is an extremely educated and articulate man.
 O'NEILL (CONT)- Very well versed in all the languages –

- 09.38.18 THOR- You have led your people into the galaxy through the Stargate. You are our choice, O'Neill. Further instructions to aid you in preparation will follow.
- 09.53.19 O'NEILL- Well... there you go.
- 09.59.04 DANIEL- Cronos was among the earliest Greek gods, one of twelve titans who eventually ascended to supreme domination.

DANIEL (OS CONT)- He was God of fate, and eventually became father to Zeus, Hera, Poseidon, and Hades.

DANIEL (CONT)- Now, this last relationship may indicate a connection to the Goa'uld Sokar.

10.14.03 TEAL'C- Cronos is the most infulential of the System Lords. It was he who originally banished Sokar.

TEAL'C (OS CONT)- Cronos was also a mortal enemy of Apophis.

- 10.23.16 DANIEL- Which may indicate why the System Lords didn't join in Apophis' attack on Earth.
- 10.27.22 TEAL'C (OS)- The System Lords...

TEAL'C (CONT)- ... reluctantly banded together to defend Goa'uld territory against outside threats, such as the Asgard and the Reetou.

TEAL'C (OS CONT)- However, they still battle amongst themselves...

TEAL'C (CONT)- ... for control of their individual domains.

10.39.12 DANIEL- Uh, the second Goa'uld representative we're expecting is Yu.

10.44.09 O'NEILL- Me?

10.46.00 DANIEL- Yu is the name of the Goa'uld.

10.49.02 O'NEILL- Ah. Sorry.

10.52.05 DANIEL (OS)- Also known as...

DANIEL (CONT)- ... Yu the Great. He did not assume the role of a god per se, but may have been one of China's earliest emperors. Legend says he possessed great mythic powers, and sprang into the world from a dragon's body.

DANIEL (OS CONT)- Ancient scrolls say that he founded the first recorded dynasty whose advances came about under harsh rule. However, it should be noted that Yu did account...

DANIEL (CONT)- ... for a number of positive influences.

11.15.09 O'NEILL- Thank you. (beat) Sorry.

11.21.17 DANIEL- According to Thor's message, Yu is the most likely to favor this treaty... DANIEL (OS CONT)- ... as his interests no longer reside in this area of the Galaxy.

11.28.06 HAMMOND- And the third Goa'uld, Dr. Jackson?

11.32.22 DANIEL- Another one we haven't met, but have a certain familiarty with.
DANIEL (OS CONT)- For those in the room who don't know, Nirrti is the Goa'uld...
DANIEL (CONT)- ...who wiped out all but one survivor of P8X-987...
DANIEL (OS CONT)- ...along with four members of the SGC, in an attempt to destroy Earth's Stargate.

11.48.15 CARTER- Cassandra's planet.

11.51.16 DANIEL- Little is known about Niirti from Earth's perspective. In early Hindu reference, she was the destructive Goddess...

DANIEL (OS CONT)- ... of darkness.

11.58.21 CARTER- So we're gonna let these Goa'uld just walk in here...?

12.02.17 HAMMOND- There are a number of aspects of this situation I am not comfortable... HAMMOND (OS CONT)-...with, Major.

> HAMMOND (CONT)- Thank you, Doctor Jackson. Teal'c, I would like you to act as liason to the Goa'uld. Dr. Jackson –

12.18.07 TEAL'C- General Hammond?

12.20.00 HAMMOND- Is there a problem?

12.21.09 TEAL'C (OS)- I mean no disrespect,...

TEAL'C (CONT)- ... but I have given my allegiance to you, to the SGC, and to the people of this world freely. I will, however, not see to the petty needs of these Goa'uld.

12.35.19 DANIEL- I'll see to the petty needs of the Goa'uld, sir.

12.40.05 HAMMOND- Okay, Dr. Jackson. Teal'c, you will assist Major...
 HAMMOND (OS CONT)- ... Castleman with base security. According to Thor, treaty laws will not permit...

HAMMOND (CONT)- ... weapons of any kind in this facility during these negotiations.

12.51.11 O'NEILL (OS)- Oh!

O'NEILL (CONT)- Sir? That doesn't sound wise.

12.56.10 HAMMOND- We're largely trusting the Asgard based on your word, Colonel.

HAMMOND (OS CONT)- This is their rule. As a result, the base is completely...

HAMMOND (CONT)- ... sealed off from the surface. The Secretary...

- HAMMOND (OS CONT)- ... of Defense will be staying to represent the President. Storage room 12-A...
- HAMMOND (CONT)- ... on level seventeen will be converted to a meeting room for security reasons. You have all received...
- HAMMOND (OS CONT)- ... folders that include your individual assignments and preparation instructions as laid out by the Asgard.

HAMMOND (CONT)- There's a lot of work to do, people, and not much time.

13.41.12 ZIPLINSKI- What about that one, Major?

13.44.05CARTER (OS)- This is a Goa'uld healing device.CARTER (CONT)- Those two are the weapons.

13.56.00 O'NEILL- General.

- 13.57.07 HAMMOND- Colonel! How are your briefings going?
- 13.59.11 O'NEILL- I had no idea how exciting diplomacy could be, sir. What's this about?
- 14.04.04 HAMMOND- I'm not sure. It's Teal'c. Teal'c... Sergeant... What's the problem?
- 14.10.04 ZIPLINSKI- He won't relinquish his weapon, sir.
- 14.13.02 O'NEILL- Teal'c?
- 14.14.13 TEAL'C- Like you, I do not believe we should remove all weapons from this base.

14.18.09 HAMMOND (OS)- The Asgards were explicit.

HAMMOND (CONT)- If they detect weapons, there will be no summit.

14.22.17 O'NEILL- No summit, no treaty.

14.24.06 TEAL'C- The Goa'uld that you are allowing through your Stargate are among the most deceptive and treacherous that I have ever known.

14.29.09 HAMMOND (OS)- Thor has assured us the Goa'ulds... HAMMOND (CONT)- ... are also forbidden from bringing weapons. 14.33.19 O'NEILL- If this treaty doesn't happen, they're gonna send a hundred of those mother ships here.

O'NEILL (OS CONT)- You know as well as I do what that means.

14.39.14 HAMMOND (OS)- Teal'c,...

HAMMOND (CONT)- I'm ordering you to turn your weapon over.

- 14.56.15 P.A. ANNOUNCER (VO FILTERED)- Checkpoints are being sealed. Levels 3 through 28 are now off-limits to all unauthorized personnel. T-minus nine minutes to arrival.
- 15.13.00 SCREEN READS: INCOMING

15.28.24 TECHNICIAN- Chevron seven is locked. Off world activation.

16.03.22 DANIEL- Here we are.
 DANIEL (OS CONT)- The V.I.P. Room.
 DANIEL (CONT)- That's, uh, an acronym. It means very important. I hope this is okay.

16.21.07 CRONOS (DISTORTED) (OS)- Your idea... CRONOS (CONT)- ... of accomodation is pitiful.

16.28.10 DANIEL- Well, it's the best we could –

16.29.20 YU (DISTORTED) (OS)- We will not stand for this!

16.33.09 CRONOS (DISTORTED)- What is this about? (beat) Sholva!

16.40.17 TEAL'C- Onack holka shakna!

16.42.20 CRONOS (DISTORTED)- Treena arick croonaka sholva.

16.48.22 DANIEL- What's going on?

16.50.25 NIIRTI (DISTORTED)- Your crude surveillance devices were poorly hidden in our quarters.

16.55.12 DANIEL- Well, that's because they're not hidden. They're security cameras, and they're for your own safety.

17.01.13 TEAL'C- As I was trying to explain.

17.02.27 CRONOS (DISTORTED)- I will not be spied upon!

17.05.07 NIIRTI (DISTORTED)- Nor will I!

DANIEL- Well, no offense was meant by it. It's merely a security precaution.
 DANIEL (OS CONT)- I'll ask if we can remove the cameras from the rooms, but we'd...
 DANIEL (CONT)- ... definitely like to leave them in the halls.

17.24.23 CRONOS (DISTORTED)- Do not show your face to me again, Sholva.

17.27.27 TEAL'C- Kelmar tokeem.

17.39.10 TEAL'C- As First Prime of Apophis, I often battled with the Jaffa of Cronos.

- 17.45.21 DANIEL- Well, you must have battled lots of rival Goa'ulds. I'm sorry, Teal'c, but that looked a little more personal to me.
- 17.59.10 TEAL'C- My father was once First Prime of Cronos. When I was but a child, Cronos commanded my father to attack a Goa'uld who was more powerful at the time. It was an impossible battle to win. When all was inevitably lost, Cronos killed my father as punishment, and exiled my mother and I. We fled to Chulak. I vowed I would beome the strongest Jaffa I could, so one day I would be named First Prime of Apophis, swom ememy of Cronos.
- 18.45.26 HAMMOND- I trust our guests are settled.
- 18.49.02 TEAL'C- The Goa'uld demanded the security cameras be removed from their quarters.

18.52.25 HAMMOND- Well, I assume you told them no.

18.55.06 DANIEL- Actually, sir, I, I kind of told them it would be okay.
 DANIEL (OS CONT)- I told them we'd have to leave them in the halls... Sort of a...
 DANIEL (CONT)- ... compromise...

19.04.06 HAMMOND- If you think it's absolutely necessary.

- 19.06.06 DANIEL- Yes.
- 19.15.10 DANIEL- Are you gonna be okay?

19.16.22 TEAL'C- I will.

- 19.22.19 CARTER- Just wanted to wish you luck, sir.
- 19.25.24 O'NEILL- Thank you, Captain... Major.
- 19.29.07 CARTER- Nervous?
- 19.36.12 O'NEILL- I wouldn't call it nervous. Confused. I have no idea why I'm here.

19.37.26 CARTER- Well, the Asgard obviously have confidence in you, sir, as do the rest of us. I know I couldn't do it.

19.43.02 O'NEILL- Why?

19.44.07 CARTER- Well, I didn't want to say anything, because I wasn't sure until I saw his face. But I think Cronos is the one who sent the Ashrac to kill Jolinar. I just hate having them here.

19.56.13 O'NEILL- Major... I hate having them anywhere. (beat) Ooops.

- 20.07.27 CARTER- Good luck, Colonel.
- 20.10.25 O'NEILL- Hello. Come on in. Have a seat. Thank you, Doctor Jackson. Hello, Yu. Well, I guess we're just, uh... (beat) And here he is. Gang's all here. You all know each other. Guess we can get started.
- 20.42.28 THOR (OS)- The Asgard High Council... THOR (CONT)- ... wishes you all greetings and thanks for this opportunity to negotiate for peace.
- 20.40.08 YU (DISTORTED)- The Goa'uld System Lords are prepared to hear the Asgard proposal.
- 20.55.03 NIIRTI (DISTORTED)- Onak aric cree.
- 20.57.15 CRONOS (DISTORTED)- Koracca aseemu!
- 21.00.14 YU (DISTORTED)- Kornak cree! Keena aric Asgard.

21.05.25 O'NEILL- I thought we were all gonna speak the same language here.

- 21.10.18 CRONOS (DISTORTED)- Gonach!
- 21.15.22 O'NEILL- What? (beat) What'd I say?
- 21.21.22 THOR- You insulted them.
- 21.25.00 O'NEILL- I insulted <u>them</u>?
- 21.26.14 THOR- By speaking out of turn. THOR (OS CONT)- This was to be expected.
- 21.31.19 O'NEILL- What are you talking about? They were yelling at each other before I said a word.
- 21.34.28 THOR (OS)- The System Lords have a fragile relationship with one another,... THOR (CONT)- ..as do we with them.
- 21.39.24 O'NEILL- You mean they're always like that?
- 21.42.15 DANIEL (OS)- Excuse me. DANIEL (CONT)- Sorry for interrupting. What just happened?

21.46.04 O'NEILL (OS)- Apparently...

O'NEILL (CONT)- ... we said hello, insulted each other, and broke for recess. Can I ask you something. (beat) Why did you let the Goa'uld get that much power in the first place? I mean, if you've got the technology...

22.02.00 THOR- We are not proud of the fact that we have been forced to ignore the situation as long as we have.

THOR (OS CONT)- But you must understand, there are other concerns for the Asgard. THOR (CONT)- We have an enemy in our home galaxy that is far worse than the Goa'uld.

22.16.13 DANIEL- Worse?

22.17.18 THOR (OS)- I cannot explain further.

THOR (CONT)- For now, we use what limited resources we can spare to enforce these treaties with the Goa'uld.

22.25.00 DANIEL- What happens if, uh, a rogue Goa'uld like Sokar who's been banished by the System Lords, decides to come after us?

22.32.02 THOR (OS)- In order to maintain...

THOR (CONT)-... the treaty, the System Lords would attempt to prevent it.

THOR (OS CONT)- Our greatest advantage has been the feudal nature of the Goa'uld. Our greatest concerr...

THOR (CONT)- ... has been a single Goa'uld rising to dominant power.

THOR (OS CONT)- If Sokar were to overtake the System Lord collective,...

THOR (CONT)- ... the Asgard may not have sufficient power to stop him.

22.51.17 O'NEILL- So, basically, you guys are bluffing the Goa'uld... big time.
O'NEILL (OS CONT)- And so far, they've been so...

23.03.09 THOR- I must return to my ship now. It will take time until the System Lords will be willing to reconvene. You may contact me with this.

THOR (OS CONT)- It will work as long as my ship is in orbit.

- 23.27.25 O'NEILL- How?
- 23.29.05 THOR- Hold it in your hand and speak.
- 23.34.01 O'NEILL- Thanks.
- 23.35.17 DANIEL- We appreciate what you're doing.

23.37.16 THOR- These negotiations will not be easy.

THOR (OS CONT)- The Asgard will be required to...

THOR (CONT)- ... make great sacrifices, as will you.

23.57.19 O'NEILL- The fate of the world in my hands, and I screw it up.

- 24.01.12 SECRETARY- I take it you apologized.
- 24.03.14 O'NEILL- Oh, I tried. They wouldn't see me.
- 24.07.05 HAMMOND- What now?

24.09.04 O'NEILL- Well, Daniel typed up a formal letter, in Goa'uld, and I signed it. That boy can really grovel when he has to.

24.16.16 SECRETARY- It's probably part of their negotiating strategy.

24.20.10 O'NEILL- I hope so. 'Cause Thor made it pretty clear that we may have to give up something big.

24.35.03 TEAL'C (OS)- As you have said, O'Neill,...

TEAL'C (CONT)- ... the alternative could be far worse.

24.43.00 DANIEL- They're ready.

24.55.27 YU (DISTORTED)- We accept the apology of the human representative, and agree to hear the Asgard proposal.

25.04.11 THOR- In return for Earth's inclusion in the Protected Planets Treaty, addendum 10815, the Asgard will allow Goa'uld access to the passage of Nilor.

25.15.20 YU (DISTORTED)- According to treaty law, section 326,...

YU (OS CONT)- ... no human planet will be allowed...

- YU (CONT)- ... to advance technologically to a point where they may become a threat to the Goa'uld.
- 25.28.18 THOR- You are correct.

25.30.03 NIIRTI (DISTORTED) (OS)- Definition of...

NIIRTI (CONT)- ... such threat shall rest solely in the hands of the Goa'uld System Lords.

- 25.35.18 O'NEILL- What?! Sorry. May I ask a question?
- 25.46.04 THOR- The human representative is recognized.

25.48.23 O'NEILL- Thank you. Are you saying you're limiting our development?

25.55.04 CRONOS (DISTORTED) (OS)- The treaty... CRONOS (CONT)- ... recognizes that the human species exists for the purpose of serving the Goa'uld as hosts and slaves.

26.04.07 O'NEILL- Excuse me...?

26.07.04 THOR (OS)- Do the System Lords accept the Asgard proposal?

26.14.15 YU (DISTORTED)- The Goa'uld System Lords accept the Asgard proposal...

YU (OS CONT)- ... and demand one additional concession.

YU (CONT)- We order the immediate and unconditional forfeiture of the Tauri Stargate. (beat) Both of them.

- 26.45.10 DANIEL (OS)- Are we... DANIEL- ... seriously going to give up gate travel?
- 26.49.04 HAMMOND- Considering the alternative...

26.51.19 SECRETARY- I believe that ring out there is the single most important thing on this planet. And I understand what losing the gate would mean. But it is on your word... SECRETARY (OS CONT)- ... that we trust these Asgard, and peaceful solutions to this

crisis must be considered.

27.06.00 O'NEILL- True, but -

27.06.24 CARTER- The point is, sir, with all due respect... It's not nearly as simple as you make it.

27.11.18 TEAL'C- There are other threats to this world this treaty will not protect you from.

27.14.13 O'NEILL- From what my buddy Thor tells me, an enemy far worse than the Goa'uld.

27.18.15 SECRETARY- If any of you can tell me absolutely why we should not accept this proposal, I will forward your opinion to the President, and I assure you, it will be given serious weight.

27.46.21 THOR- Have your people reached a decision?

27.49.08 O'NEILL- Um... not yet. That's kind of why I'm here. I was wondering what you think we should do.

28.01.28 THOR- It is your decision.

28.05.08 O'NEILL- I see. Or do I? Do you guys... Do you ever say one thing and mean another – kinda speak between the lines, if you know what I mean?

28.21.22 THOR- I do not.

28.22.22 O'NEILL (OS)- Do not what?

O'NEILL (CONT)- Speak between the lines or understand?

28.28.04 THOR- What do you, O'Neill, think your people should do?

28.33.04 O'NEILL- Well, see, I don't know. It's a bit much for one guy to make that call for an entire planet. On the other hand, it's pretty obvious. Give up the Stargate or be destroyed.

28.44.02 THOR- So it would seem.

28.45.16 O'NEILL (OS)- But, see, the Goa'uld could call your bluff,...
 O'NEILL (CONT)- ... attack us anyway, and we've have given up our only means of finding a way to defend ourselves.

28.52.26 THOR- That is true.

28.54.00 O'NEILL- Oh, come on! Give me something! Anything! I won't hold you to it! A little head nod, if there's another way around this...

29.02.23 THOR- It is your planet at stake. THOR (OS CONT)- I believe you have it within you... THOR (CONT)- ...to make the right decision. 29.12.14 O'NEILL- All right. Send me back. (beat) Wait! Right there... Is that a head nod? A nod is usually down and then back up. You kind of just went down. Wait, okay ---!

29.32.03 SECRETARY (INTO PHONE)- Yes sir. I understand. (TO O'NEILL) We accept the terms.

29.39.03 O'NEILL- Oh... Daniel, you want to tell them we're ready.

29.55.04 P.A. ANNOUNCER (VO FILTERED)- Security to level 25! Medical team to level 25!

30.02.09 ZIPLINSKI- In here, sir.

30.03.10 YU (DISTORTED) (OS)- I demand to know the meaning of these sounds!

30.05.04 DANIEL- Please, just stay in your rooms for a moment!

30.19.03 FRAISER- His vitals are stable, but he took quite a blow to the head. There's some intercranial swelling.

30.24.18 O'NEILL- Junior taking care of it?

30.25.27 FRAISER- Yes. His larval Goa'uld is assisting in the healing process. Hopefully, there isn't any permanent brain damage. But we won't know that 'til he wakes up.

30.33.03 HAMMOND- How long?

- 30.34.02 FRAISER- That's up to him?
- 30.36.17 O'NEILL- What about Cronos?
- 30.37.28 FRAISER- Oh, he should only be so lucky. Severe internal injuries and his host is dying.
- 30.43.11 O'NEILL- Shouldn't his snake be taking care of him?

30.46.00 FRAISER- Based on what I've learned about Goa'uld symbiology, the symbiote cannot heal injuries this severe on its own. We're doing everything we can, but I don't think he's gonna make it. It could be hours... could be minutes...

30.58.09 CARTER- I have the security videotape. You'll want to see this.

31.14.07 CARTER (OS)- The SF's assigned to guard the hallway sounded the alarm. They say Teal'c...

CARTER (CONT)- ... passed them and told them he was going to see Cronos.

31.21.12 DANIEL- Well, Niirti and Yu are demanding an explanation.

31.24.00 O'NEILL- Do we tell them?

31.25.25 CARTER (OS)- Well, based on the videotape evidence,...
 CARTER (CONT)- ... it looks like Teal'c is involved. Not that I believe he's repsonsible for this.

31.31.12 DANIEL- Well, I don't believe for a minute that Teal'c would sacrifice our interests for a personal vendetta.

31.36.20 O'NEILL- What personal vendetta?

31.41.08 DANIEL- Well, apparently, Teal'c and Cronos have some pretty heavy history.

- 31.45.04 HAMMOND- Such as...?
- 31.47.20 DANIEL- Cronos killed Teal'c's father.

31.49.19 O'NEILL- Oh, for crying out loud! Why doesn't he tell us these things? Why didn't <u>you</u> tell us?

31.57.01 DANIEL- He confided in me.

31.59.08 CARTER- I still don't think Teal'c would do this.

32.01.07 O'NEILL- Neither do I, but the case against him just got a little more interesting, don't you think?

32.06.19 DANIEL- Well, we have to tell the other Goa'ulds something.

- 32.08.15 FRAISER- If we lie, we could make things worse.
- 32.11.15 HAMMOND- Doctor...?

32.12.21 FRAISER- Sir, the point is maybe the Goa'ulds can do something for Cronos that I can't.

32.17.02 HAMMOND (OS)- Let's tell the Goa'ulds what we know. HAMMOND (CONT)- Major, find out what really happened.

- 32.21.15 CARTER- Yes sir.
- 32.37.10 NIRRTI (DISTORTED)- You will pay for this!
- 32.39.24 O'NEILL- We know it looks bad.
- 32.41.18 HAMMOND- But we're not sure what actually transpired.
- 32.44.00 YU (DISTORTED)- Whoever is responsible for this atrocity must be brought before us.
- 32.48.28 DANIEL- We're trying to figure out exactly what happened right now.
- 32.51.01 NIRRTI (DISTORTED)- All the people of your planet will suffer greatly for this crime.

32.54.26 O'NEILL- All right, just hang on a second before you go dooming everybody...

32.58.04 DANIEL (OS)- We brought you here because we... DANIEL (CONT)- ... want to know if there's anything either of you can do for him.

33.01.26 FRAISER- He's dying.

33.03.03 YU (DISTORTED) (OS)- We can do nothing...

YU (DISTORTED) (CONT)- ... here in your primitive facilities!

33.08.15 DANIEL- Okay. Can you use... DANIEL (OS CONT)- ... one of these?

33.41.18 NIRRTI (DISTORTED)- His injuries are... NIRRTI (OS CONT)- ... too severe. The only way... NIRRTI (CONT)- ... to save him is with a sarcophagus.

33.46.18 O'NEILL- Okay, we don't have one of those.

33.49.19 YU (DISTORTED) (OS)- Then we will... YU (CONT)- ... prepare to leave immediately.

33.58.08 THOR (VO)- You must let them take Cronos.

34.00.22 O'NEILL- They'll attack us.

34.02.20 THOR (OS)- If you hold them against their will,...

THOR (CONT)- ... the rest of the System Lords will attack regardless.

- 34.07.04 O'NEILL- Look, Teal'c didn't do this.
- 34.11.02 THOR (OS)- I have been instructed by...

THOR (CONT)- ... the Asgard High Council to leave Earth's orbit.

- 34.16.14 O'NEILL- And that's, what, in line with your policy of limited benevolence?
- 34.20.05 THOR- I have explained our position.
 THOR (OS CONT)- To borrow from a human euphemism,...
 THOR (CONT)- ... it is not a perfect galaxy.
- 34.28.04 O'NEILL- Yeah, well, I'm sorry. I get a little testy when faced with the total annihilation of our little corner of it.
- 34.33.09 THOR- We sympathisize with your situation.
- 34.35.23 O'NEILL- Right. And yet you'll still just sit by and watch them destroy us.

34.40.02 THOR- We cannot interfere without beginning a much larger war that cannot be won at this time.

34.50.00 YU (DISTORTED) (VO)- I command you to release us!

34.51.21 NIRRTI (DISTORTED)- We must leave now and take Cronos, before his death is on your heads.

34.56.05 HAMMOND- I'm sorry. I cannot let you go.

34.58.10 NIRRTI (DISTORTED)- If we do not report back, your planet will suffer the full force of the System Lords' wrath.

35.04.24 HAMMOND (OS)- That's going to happen whether... HAMMOND (CONT)- ...we let you go or not.

35.07.18 YU (DISTORTED)- You have violated every code mandated for these negotiations. YU (OS CONT)- The Asgard...

YU (CONT)- ... will not protect you!

35.13.17 O'NEILL- Actually, you're wrong about something. There's one rule we haven't broken yet.

35.28.04 SECRETARY- Do we have any idea what sort of time frame surrounds this impending attack?
 SECRETARY (OS CONT)- The President is readying a statement...
 SECRETARY (CONT)- ...to the United Nations. From what you're telling me, Earth should begin preparing for this onslaught immediately.

35.45.22 O'NEILL- Boy, did this get out of hand.

35.49.01 HAMMOND (INTO PHONE)- Hammond. Thank you. (TO OTHERS) Teal'c is conscious.

35.55.03 TEAL'C- Cronos requested my presence.

35.57.09 O'NEILL (OS)- So you went... O'NEILL (CONT)- ... alone?

35.59.23 TEAL'C (OS)- It is what he requested. TEAL'C (CONT)- When I arrived, he denied making the request. TEAL'C (OS CONT)- Before I could leave, we were attacked.

36.07.04 CARTER- By whom?

36.08.15 TEAL'C- An invisible force.

36.11.26 O'NEILL- Invisible force?

36.15.06 DANIEL- A Reetou?

36.18.14 HAMMOND- Could one have come through the gate with the Goa'ulds?

36.21.00 CARTER (OS)- Sir, we could break out the transphase eradication...

CARTER (CONT)- ... rods and do a sweep of the base.

36.23.08 TEAL'C- I did not sense the presence of a Reetou.

36.27.16 O'NEILL- I almost wish you had.

36.29.17 CARTER (OS)- Teal'c are you aware of...

CARTER (CONT)- ... any of the Goa'uld having some sort of stealth technology?

36.33.20 TEAL'C- I am not.

36.35.24 DANIEL- Hathor had the ability to appear... DANIEL (OS CONT)- ... and disappear.

36.38.28 O'NEILL- Okay, she's dead. (beat) Right? Please tell me she's dead.

36.45.01 CARTER- Yeah.

36.48.09 TEAL'C- I did not attack Cronos.

36.50.17 DANIEL- Well, we believe you, Teal'c, but I just don't think anyone else is going to.

36.54.11 O'NEILL- Certainly not those lying, scheming, ... O'NEILL (OS CONT)- ... no good-for-nothing slimy...

O'NEILL (CONT)- ... overdressed style mongers -

36.58.11 CARTER (OS) (OVERLAPPING)- Sir!

CARTER (CONT)- I'd like to try something.

37.03.28 O'NEILL- I wasn't finished yet.

37.14.21 FRAISER (OS)- Are you sure you know what you're doing?

37.17.13 CARTER- I've made it work before... just not on a living... thing.

37.33.19 O'NEILL (OS)- Um...

O'NEILL (CONT)- I hate to go all Freudian on you here... (beat) The part of you that knows how to run those things...

37.48.25 CARTER- You think I don't want to cure Cronos because he ordered Jolinar's death. (beat) I just have the memories of Jolinar. She doesn't control me. (beat) I'm well aware of the stakes here.

38.02.23 O'NEILL- I'm just saying...

38.37.13 CARTER- It worked...

38.40.22 CRONOS (DISTORTED)- You have healed me,...

CRONOS (OS CONT)- ... human.

CRONOS (CONT)- I am sure you spared my life only to prevent your own destruction.

38.53.07 O'NEILL- Hey! We didn't do this to you. And we saved your snaky little butt because we want the treaty to happen.

39.03.17 CRONOS (DISTORTED)- That is not possible now. Nirrti and Yu have undoubtedly blamed the Tauri for this attack on me?

39.10.18 O'NEILL- Good catch. (beat) Look, it's obvious to everybody that one of them did this to you. What if I can prove which one?

O'NEILL (OS CONT)- What's that worth to you?

39.24.20 CRONOS (DISTORTED)- What do you ask in return?

39.31.02 CARTER- We can't prove anything, sir. All we know for sure is Nirrti lied.

39.35.10 O'NEILL- But Cronos doesn't know that. And Nirrit doesn't know what else we know.

39.39.22 DANIEL- Which is nothing.

39.41.00 O'NEILL- Right. But she doesn't know we know nothing.

39.43.14 HAMMOND- What are you suggesting?

39.45.08 O'NEILL- I'm just saying, maybe it's time we took a page out of the Asgard book on dealing with these... Goa'ulds.

- 39.50.22 DANIEL- You're gonna bluff?
- 39.51.21 HAMMOND- That sounds risky, Colonel.
- 39.54.03 O'NEILL- Yes, sir.

40.00.20 O'NEILL (OS)- You lied to us about being able to heal... O'NEILL (CONT)- ... Cronos with that hand device.

40.05.25 NIRRTI (DISTORTED)- I tried honestly and failed. I was willing to save Cronos by taking him to a sarcophagus.

40.11.28 O'NEILL (OS)- Maybe you were,...

O'NEILL (CONT)- ... maybe you weren't. But the fact is you are the only Goa'uld here who has the technology to become invisible.

- 40.23.03 NIRRTI (DISTORTED)- That is a lie!
- 40.25.21 O'NEILL- Who's lying? We called the Tok'ra.

40.29.02 DANIEL (OS)- They say you've been experimenting...

DANIEL (CONT)- ... with phase shifting in order to battle the Reetou.

40.34.22 YU (DISTORTED)- You did not share this technology with the System Lords?

- 40.36.28 NIRRTI (DISTORTED)- They are lying!
- 40.38.13 YU (DISTORTED)- You dare attack Cronos and defile our meeting with the Asgard!

40.42.12 NIRRTI (DISTORTED)- It's not true!

40.43.27 YU (DISTORTED)- You are the one who opposed this treaty! YU (OS CONT)- You have long coveted Cronos' territory.

40.49.14 NIRRTI (DISTORTED)- Gonach!

40.58.01 O'NEILL- Look out!

41.11.09 CARTER- Drop the weapon. (beat) Have you ever seen one of these things work? 'Cause there's nothing more I'd like to do right now than demonstrate it.

41.46.03 O'NEILL- Cronos said he's support the treaty and we wouldn't have to give up our Stargate. I was kind of hoping we could count on your vote.

42.14.08 CRONOS (DISTORTED)- We will not attack your world. But if you continue to use your Stargate,...

CRONOS (OS CONT)- ... be warned. Anyone who is caught by one of the System Lords will be shown no mercy.

CRONOS (CONT)- They will suffer greatly.

- 42.33.00 O'NEILL- Well, that certainly makes life more interesting.
- 42.49.19 DANIEL- Boy, is she gonna get it.
- 42.52.03 O'NEILL- My heart bleeds.
