01.00.26 TEAL'C- O'Neill.

01.09.16 MAYRIS (OS)- Shhh. It was like an explosion, Orner. I heard it.

01.16.20 ORNER (OS)- There wasn't any explosion.

01.18.00 MAYRIS (OS)- I'm telling...

MAYRIS (CONT)- you, I heard something. It was a big...

01.20.24 ORNER- A big what?

01.22.02 O'NEILL- Hello? You heard us.

01.30.16 ORNER- Wh...where did you come from?

ORNER (OS CONT)- How did you get in here?

01.34.28 JACKSON- Door was open. Is there anyone around here who might be
considered...in charge?

01.44.21 ORNER- (clears throat) Me. Show me your papers.

01.50.02 JACKSON- We don't really have any papers, we're, we're travelers. We've come to
meet you.

01.54.12 ORNER- To meet me?

01.55.22 MAYRIS- Not you.

01.57.07 JACKSON- No, actually, I met your people. I'm Daniel. This is...Major Carter and...

JACKSON (OS CONT)- Jack O'Neill and, and Teal'C.

02.04.25 ORNER- Who'd give you a name like Teal'C?

02.07.25 TEAL'C- It was given by my father. It means "strength".

02.14.16 MAYRIS (OS)- You remember your father?

02.16.24 TEAL'C- For as long as I draw breath.

02.19.23 ORNER- Then...

ORNER (OS CONT)- you could have not been here at the time of...

ORNER (CONT)- the Vorlix.

02.24.20 JACKSON- The Vorlix. That doesn't...ring a bell.

02.26.28 MAYRIS- It was the day that all we know about ourselves was taken away.

02.30.09 ORNER- We can only remember the days since the Vorlix. Before that...nothing.

03.43.25 CARTER- Well...still don't detect...

CARTER (OS CONT)- anything out of the ordinary, sir. Neither did the MALC. It means we're okay.

02.50.03 O'NEILL (OS)- The MALC is useless. You...I'll trust.

03.53.14 ORNER- You needn't worry, friend. Ke'ra says that whatever it was that caused the Vorlix came and went a year ago.

03.59.18 MAYRIS- Oh at least a year. More.

04.01.14 ORNER- In the first days after the Vorlix, well, there was panic and confusion. It's hard to be exactly precise.

04.08.11 O'NEILL- So you all just woke up one day and didn't know who you were. How does that work?

04.15.06 ORNER- My first memory after the Vorlix was of running in the streets...

ORNER (OS CONT)- As though for my life.

ORNER (CONT)- And she was running right there beside me. Whoever she is.

04.26.00 CARTER- It seems like some kind of mass...

(CONT)- (OS CONT)- amnesia, sir.

04.30.01 O'NEILL- Hmm?

04.31.03 CARTER- It happened to a friend of mine during the Gulf War. Her chopper went down and she was knocked out. When she came to, her memories and identity before the crash were gone.

04.39.05 O'NEILL- So everybody on this planet took a hit to the head?

04.41.23 CARTER- Look. No...sir. I...I'm not sure what could cause something like amnesia
on this scale.

04.47.00 TEAL'C- I've never before encountered such an occurrence.

04.49.21 ORNER- All of our elders are missing as well.

04.52.02 O'NEILL- You remember elders?

04.53.21 ORNER- Uhh....no. But there are photographs of them in every house.

04.56.23 MAYRIS- And the children are gone too.

04.58.20 ORNER- If we ever had children.

05.00.11 MAYRIS- Well, we weren't grown on trees. We came from somewhere.

05.02.25 ORNER (OS)- Then why have we photographs of elders and none of the children,
hmm? Answer...

ORNER (CONT)- me that. (scoffs) Daft. But if you do have any information we could
use...you must seek Ke'ra.

- 05.14.00 JACKSON- That's the second time you mentioned that name.
- 05.17.01 MAYRIS- You don't know who Ke'ra is.
- 05.19.11 ORNER- She's Minister of Health, Science and re-structuring the Vyus transitional government.
- 05.23.25 O'NEILL- Busy gal.
- 05.25.08 MAYRIS- We're all busy.
- 05.25.28 ORNER- Well, we would be lost without her. And you know it.
- 05.30.11 O'NEILL- Well. After you.
- 05.36.15 MAYRIS (OS)- You needn't flatter the woman when she isn't even in the room.
- 05.40.15 ORNER- I'll take them. You go home.
- 05.42.23 MAYRIS- Well don't expect supper.
- 05.44.10 ORNER- Never do. Ke'ra. There are some people here who want to see you.
- 06.06.17 KE'RA- They'll have to wait for the moment, Orner. Does that help?

06.09.12 PATIENT- No. I can't (gasps)...breathe.

06.14.22 KE'RA (OS)- Those with allergies...
KE'RA (CONT)- to foods can't remember them.

06.17.14 CARTER- Well, it looks like she's going into anaphylactic shock.

06.20.28 KE'RA- Breathe now. (unintelligible) Better?

06.27.04 PATIENT- (gasps) Yes. Thank you.

06.30.21 KE'RA- Rest here a while. Orner. You were about to introduce your friends.

06.42.08 ORNER- They are travelers, Ke'ra. From far away.

06.45.13 KE'RA- I can see that.

06.48.12 O'NEILL (OS)-Uhhh...
O'NEILL (CONT)- O'Neill, Carter...
O'NEILL (OS CONT)- Daniel and Teal'C.

06.52.19 JACKSON (OS)- So, I'm...
JACKSON (CONT)- guessing you were, errr, are a doctor.

06.56.28 KE'RA- It seems to me that before the Vorlix I helped others. That is all that I sense.
Are you?

07.04.00 JACKSON- A doctor? No, no. Well, well, yes. Umm, of...I'm a Doctor of
Archaeology. I study the past.

07.13.10 KE'RA- Then you are most welcome to be here, Daniel.

07.17.00 ORNER- They were not here at the time of the Vorlix.

07.21.10 KE'RA- You've done absolutely the right thing in bringing them here, Orner. Thank
you. He fervently believes that we are husband and wife and...that we need
not wait until we regain our memories in order to renew our relationship.
Perhaps you can help us. Please. Follow me. This room has all of the
research we've been able to recover since the Vorlix. I spend every waking
hour in here. Reading, searching...

KE'RA (OS CONT)- Dispensing whatever useful information I find.

KE'RA (CONT)- If you were able to help us, I know our people would be eternally
grateful.

08.20.03 O'NEILL- You seem to have everything under control.

- 09.32.28 KE'RA- On the contrary, sir. We're falling apart. Industry and agri-
KE'RA (OS CONT)-...culture on Vyus has come to a halt.
KE'RA (CONT)- When winter comes, it will be disastrous.
KE'RA (OS CONT)- Nothing less.
KE'RA (CONT)- You're not from Vyus.
- 08.38.13 O'NEILL- What gave us away?
- 08.40.14 KE'RA- Wh...Whatever agent caused the Vorlix is gone, but its effects were
pandemic. If you know who you are, than you cannot be of this world.
- 08.49.02 O'NEILL- Oh. Well you know that big, round ring thing you got stashed in that
warehouse down the road?
- 08.55.22 KE'RA- So it is a transportation device.
- 08.58.03 TEAL'C (OS)- So it is.
- 08.59.09 CARTER- We call it a Stargate.

- 09.01.11 KE'RA- Stargate, yes. Umm, Doctor Zirvis mentioned that word in his research.
Though I have given up hope of ever finding this Doctor Zirvis amongst our people, his papers have taught me much. Here: "Our visitor claims to have come to Vyus from beyond the stars themselves, though I still cannot comprehend the science behind this Stargate device she claims to have used." I have studied this device since, but have been unable to activate it.
- 09.36.01 JACKSON- Ah, Ke'ra. Could you go back to that part about the visitor again?
- 09.40.15 KE'RA (OS)- She's mentioned many times in the archive.
- 09.43.02 CARTER- What can you tell us about her?
- 09.45.00 KE'RA- That she was somewhat of an apothecary.
KE'RA (OS CONT)- And that she did not survive the Vorlix.
- 09.50.21 O'NEILL- How do you know that?
- 09.51.11 KE'RA- The bodies of an elder woman and man were discovered some days later in a building that was destroyed in an explosion. The only remains of our elders we have found. We deduced the male must have been Doctor Zirvis and the female matches what little description he gave in his notes of the visitor.
- 10.06.27 TEAL'C- What is the name of this elder woman?

- 10.08.23 KE'RA- It is mentioned. Here, yes. She calls herself "Linea".
- 10.34.25 FRASIER- Colonel?
- 10.36.16 O'NEILL- Oh hi. What's your name?
- 10.39.26 TEAL'C- I have informed Doctor Frasier that we may have located the planet to which
Linea escaped.
- 10.43.17 O'NEILL- Possibly. I'd like to know what we're dealing with...
O'NEILL (OS CONT)- here.
- 10.47.07 FRASIER- Sounds like a world-class case of amnesia.
- 10.50.21 O'NEILL- Check these people out, will ya?
- 10.52.14 FRASIER- Yes, sir. I'll find out what I can. Let's, umm, set up over here.
- 10.59.21 JACKSON (OS)- I keep finding references...
JACKSON (CONT)- to something called Dargol.
- 11.03.00 KE'RA- Yes, I found Dargol was a chemical once used as a pesticide. It seems to
have had a significant impact on the environment and has since been banned.

- 11.12.05 JACKSON- Yes, we had a similar problem on my world with a chemical...
JACKSON (OS CONT)- called DDT. It built up in the food chain until entire species were threatened.
- 11.20.22 KE'RA (OS)- Yes. I first...
KE'RA (CONT)- believed that this Dargol was related to our loss of memory in much the same way, but there's little evidence of it. I have found residue only in the bodies of those who have died since the Vorlix.
- 11.44.03 JACKSON- What?
- 11.46.07 KE'RA- Sometimes images of the people in the archives look familiar...
KE'RA (OS CONT)- to me. I wonder if, if I knew this person or that person.
KE'RA (CONT)- There are still so many questions. Why are there no images of children and...where have our elders gone? Through your Stargate perhaps.
- 12.03.15 JACKSON- Well, I suppose it's possible that your people foresaw a disaster coming and sent the most helpless to safety.
- 12.09.18 KE'RA- No, Daniel. Whatever happened, happened quickly without warning.
- 12.14.01 JACKSON- How do you know that? Because if you saw disaster coming, you would have...left yourselves a note?

- 12.22.21 KE'RA- (laughs)
- 12.25.02 JACKSON- Sort of a..."to whom it may concern"?
- 12.28.23 KE'RA- (laughs)
- 12.36.14 CARTER- Sir?
- 12.39.22 O'NEILL- Oh. I was just thinking about amnesia. That doesn't quite track with Linea's
nickname.
- 12.50.16 TEAL'C- "Destroyer of Worlds."
- 12.52.07 O'NEILL- Yeah. That one.
- 12.53.20 CARTER- Well actually, in sort of a sick way, it does.
CARTER (OS CONT)- I mean Ke'ra said herself their society was on the verge of...
CARTER (CONT)- collapse. Despite their efforts. This world is in trouble, sir.
- 13.02.28 TEAL'C- Perhaps Linea was experimenting with other ways in which to destroy...
TEAL'C (OS CONT)- worlds.
- 13.06.19 O'NEILL- Variety being the spice of life and all?

- 13.09.04 CARTER (OS)- The fact is, sir...
- CARTER (CONT)- We let Linea out of Hadante prison. We gave her everything she
need to know about the network of Stargates...
- CARTER (OS CONT)- to go anywhere she wanted.
- 13.18.10 O'NEILL- I know.
- 13.19.15 CARTER- We're responsible, sir.
- 13.21.24 O'NEILL- I know.
- 13.27.01 KE'RA- Tell me of Linea.
- 13.29.23 JACKSON- Ooh, well. Ahh. Basically, we met her on a visit to another world during
which we were imprisoned. Unjustly. And Linea helped us escape.
- 13.40.27 KE'RA- Well surely there was nothing wrong with that if you were imprisoned unjustly.
- 13.45.08 JACKSON- W...well, she was imprisoned justly.
- JACKSON (OS CONT)- It was only after we escaped that we learned that this...
- JACKSON (CONT)- nice, older lady we thought Linea was, was in fact a bad, older
lady who had committed terrible crimes.
- 13.59.26 KE'RA- What crimes?

- 14.01.27 JACKSON- She created a plague that almost wiped out an entire people.
JACKSON (OS CONT)- They called her "Destroyer of Worlds". She found your world because of us through on of our computers. And that's why we're going to do everything in our power to help.
- 14.18.19 KE'RA- I know you will.
- 14.32.15 CARTER (OS)- I may have something.
- 14.35.08 O'NEILL (OS)-What?
- 14.37.28 CARTER- I think it's Linea's diary.
CARTER (OS CONT)- I remember seeing her with it.
- 14.45.06 FRASIER- (sighs) Your diagnosis was bang-on, Major. Now, sir.
FRASIER (OS CONT)- I can either take the next several weeks setting up a lab here to study the problem...
FRASIER (CONT)- going back and forth for computer analysis, or we can go back with these...
FRASIER (OS CONT)- volunteers, do a series of...
FRASIER (CONT)- MRI's and get the answers we need a lot faster.
- 15.00.15 KE'RA- I would be glad to volunteer.
KE'RA (OS CONT)- And so would others.

- 15.03.14 FRASIER- As long as we maintain proper quarantine procedures, it shouldn't be a problem, sir.
- 15.09.08 O'NEILL- All right. I'll go on back and brief Hammond.
- 15.12.06 KE'RA- I believe I can help.
- 15.14.17 FRASIER- I'm sure you can.
- 16.00.14 JACKSON- You guys go ahead, show 'em how easy it is.
- 16.03.05 CARTER- See you on the other side.
- 16.12.16 ORNER- I...I can't.
- 16.13.16 KE'RA- Orner, trust these people. As you trust me. (gasps)
- 16.43.11 JACKSON- You all right?
- 16.44.21 KE'RA- Incredible.
- 16.47.21 ORNER- Am I in one piece?
- 16.48.25 MAYRIS- Yes, Orner. One skinny, little piece.

- 16.58.21 JACKSON- General Hammond. This is Ke'ra.
- 17.01.15 HAMMOND- It's a pleasure, Ke'ra.
- 17.03.00 KE'RA- On behalf of the transitional government of Vyus, we...thank you for your
generosity and your support, General.
- 17.11.06 O'NEILL- Daniel? You wanna show them to the infirmary?
- 17.13.18 JACKSON- Right.
- 17.15.04 KE'RA- Thank you.
- 17.23.03 HAMMOND- Colonel. What if Doctor Frasier is unable to reverse whatever caused
this?
- 17.30.01 O'NEILL- I don't know.
- 17.33.23 FRASIER (OS)- Now if you look at the blue areas, you'll see that you all have the
same identical obstructions in the temporal lobes and hippocampus sections of
your brain. I'm not exactly sure what it is, except it's some sort of residue
between the synapses. So it's possible your old memories are intact, they're
just not accessible.

- 17.50.26 JACKSON- So their memories are just blocked.
- 17.53.00 FRASIER- Literally, yes.
- 17.54.04 KE'RA- And does this material match the Dargol residue that I gave you?
- 17.57.12 FRASIER- We should be able to confirm that very quickly. And if it can be dissolved
or removed without damaging the neurons...
- 18.03.05 MAYRIS- Then we can be cured.
- 18.05.15 KE'RA- We need only to find the right medicine to dissolve the residue.
- 18.08.15 FRASIER- Uh...that is much more difficult than it sounds.
- 18.11.07 KE'RA- Well then we should get started immediately.
- 18.13.05 FRASIER- Ah...Ke'ra. We've already been at it for a long time and I still have some
tests to run, so...
- 18.18.22 JACKSON- So...why don't I give you the fifty-cent tour?
- 18.21.15 FRASIER- Yes.

18.26.06 KE'RA- Thank you.

18.27.00 FRASIER (OS)- Okay. (sighs)

18.41.28 KE'RA (OS)- Your complex is incredible, Daniel. Your...

KE'RA (CONT)- technology. I never dreamed of such marvels. Thank you.

18.48.24 JACKSON- You're welcome.

18.49.25 KERA- (laughs) Is it...is it morning or night on the surface? May we see for
ourselves?

18.54.06 JACKSON- Uh. No, not yet. Soon though, I hope.

18.56.27 KE'RA- I hope so too. (giggles)

18.59.06 JACKSON (OS)- So this is it. Uhhh...it's not much of...

JACKSON (CONT)- a view, but it's got all the comforts of...

19.04.11 KE'RA (OS)- You've been very kind.

KE'RA (CONT)- Thank you.

19.10.20 JACKSON- Uh, so there...

JACKSON (OS CONT)- are clothes in the dresser...uhh.....(unintelligible) sort of a...

- 19.16.17 KE'RA (INTERRUPTING)- Is my clothing unsuitable?
- 19.18.00 JACKSON (OVERLAPPING)- ...fits you. No! No, no, no, no, it's...no, it's umm...it's fine. I was just...uh...are you hungry? (stammers) cuz...I can...I can...I can have them send something down. So. You're hungry. I'm hungry. I'm gonna have them send something down. You...you want something?
- 19.40.03 KE'RA- Yes.
- 19.41.00 JACKSON- Right.
- 19.43.05 KE'RA- Since the Vorlix, close contact has become...almost taboo. They're afraid that if we were ever able to regain our memories...
- 19.52.07 JACKSON- Mmm. You would find yourself waking up beside the wrong person.
- 19.55.22 KE'RA- But you...are not from Vyus.
- 19.58.22 JACKSON- No, I'm not from...there. From Vyus, no. No. (sighs)
Ke'ra.
- 20.08.04 KE'RA- I understand.

- 20.09.02 JACKSON- No. You don't. I mean...I'm...umm. Okay. I'm finding myself very, very... *very*. But uhh...umm...the fact is I've only just recently lost my wife.
- 20.28.28 KE'RA (OS)- Oh
- 20.29.05 JACKSON- And uhh...well that's not actually totally true. I mean I actually lost her a long time ago. But the fact is, I don't think right now I would trust myself completely too well...
- 20.55.01 KE'RA- I'm sorry. I interrupted you.
- 20.56.17 JACKSON- No, you didn't. No, I uh...I wasn't going to say anything else...
- 20.59.11 KE'RA (INTERRUPTING)- I had to do that.
- 21.00.15 JACKSON (OVERLAPPING)- (unintelligible)...what?
- 21.01.09 KE'RA- I had to do that. I had to do that in case...when my memory returns, I find myself attached to someone else and...I'm not able to ever do it again.
- 21.10.24 JACKSON- Right. I understand. That's...that's probably why I should do this.
- 21.30.05 O'NEILL- You were lookin' for me?

- 21.31.15 CARTER- Yes, sir. I've been studying Linea's journals. Apparently she found a link between Dargol—it's a...chemical pesticide the Vyans used—and longevity.
- 21.41.23 O'NEILL- What's a bug spray have to do with longevity?
- 21.44.06 CARTER- Well, it seems that it was having the effect of slowing the aging process. Not in an extreme way, but certainly significant enough.
- 21.51.00 O'NEILL- Lucky bugs.
- 21.52.00 CARTER (OS)- Yes and no.
CARTER (CONT)- They stopped using it over twenty years ago. It was adversely affecting their fertility rate.
- 21.59.09 O'NEILL- So, no kids.
- 22.00.18 CARTER- Right. The point is, Linea was trying to enhance the life extending properties of Dargol to create a sort of fountain of youth.
- 22.08.20 O'NEILL- She was trying to make herself young again?
- 22.11.05 CARTER- According to her last entry, Linea was about to conduct some controlled lab experiments using an intensely concentrated form of Dargol. On two Vyan elders. A male and a female.

- 22.22.23 O'NEILL- And?
- 22.24.25 CARTER- Annnd...that's where her journal ends.
- 22.27.25 O'NEILL- Ah. The Vorlix, perhaps?
- 22.32.14 CARTER- Exactly. Now what if there really was a laboratory accident?
CARTER (OS CONT)- Some massive chain reaction of enhanced Dargol gas...
CARTER (CONT)- that caught even Linea by surprise. The entire population
becomes young again. Overnight. You realize, of course, the implication.
- 22.47.26 O'NEILL- No.
- 22.52.10 CARTER- Umm. Their elders aren't missing, sir. They are the elders. The fountain of
youth worked. The amnesia was simply a side effect Linea didn't see coming.
- 23.04.12 O'NEILL- Uh....wait a minute. Linea is dead, right?
- 23.10.06 CARTER- Well, if those two bodies that Ke'ra found really were the Vyan elders that
Linea was experimenting on...
- 23.16.12 O'NEILL- Don't say it, Carter.
- 23.17.25 CARTER- Sir. We wouldn't recognize her even if she walked through the front door.

23.20.12 O'NEILL- Don't. Don't... a la, la, la, la, la...

23.22.15 CARTER- Sir...

23.22.16 O'NEILL (OVERLAPPING)- ...la la la la...

23.22.28 CARTER- She has the knowledge of chemistry, the medical skills. I think we have to
at least face the possibility that Ke'ra is Linea.

23.36.14 HAMMOND (OS)- Then she's also a victim of the amnesia?

23.39.10 O'NEILL (OS)- It fits.

23.41.00 JACKSON- It fits. Well what about the body of the old woman they found after the
Vorlix that fits Linea's description?

23.47.15 TEAL'C- Linea's first victim.

23.49.15 O'NEILL- Come on, Daniel. You saw the test results. What more do you need?

23.52.19 FRASIER- Ke'ra's DNA is a perfect match with the samples I took from Linea last
year. It's irrefutable.

- 23.57.00 JACKSON- Irrefutable! Okay. So let's just lock her up and throw away the key, then.
Or better yet, we could send her back to the prison where we found her.
- 24.03.24 O'NEILL- Linea, Daniel. She used to be Linea. We're lucky she didn't knock us off
the first time around.
- 24.11.24 JACKSON (OS)- Let me ask you a question.
JACKSON (CONT)- Who would you trust with your life more than anyone else in the
world? Don't worry, I won't be offended if you don't pick me. Could it be Teal'C?
- 24.20.21 O'NEILL- Sure.
- 24.21.29 JACKSON (OS)- Uh, Teal'C, just refresh my memory.
JACKSON (CONT)- What was your previous occupation?
- 24.28.04 TEAL'C- I was First Prime of Apophis.
- 24.30.01 JACKSON- Right. Did a few nasty things back then?
- 24.33.29 O'NEILL- We see the subtle point you're trying...
O'NEILL (OS CONT)- to make.

24.36.10 JACKSON- No you don't. She is not the same person. She is not who she used to be. Let's not condemn her for who she may have been...

JACKSON (OS CONT)- in the past.

24.52.27 HAMMOND (OS)- I think it would be...

HAMMOND (CONT)- prudent to keep her confined to her quarters until we can resolve...

HAMMOND (OS CONT)- the Vyan's medical crisis.

HAMMOND (CONT)- Colonel O'Neill. Perhaps you could inform...

25.01.24 JACKSON (INTERRUPTING)- I'll inform her.

25.15.08 KE'RA- Daniel. What's wrong? We have work to do.

25.29.03 JACKSON- Nothing. There are... quarantine procedures that General Hammond is insisting on. He's uh...you have to stay here a while.

25.39.00 KE'RA- But the effects of the Vorlix are not contagious.

25.41.07 JACKSON (OS)- I know.

25.42.02 KE'RA- Then why?

25.46.04 JACKSON- I can't tell you everything but I can tell you that more happened during the Vorlix than just losing your memories.

25.52.04 KE'RA- Is that why there are now guards outside my door?

25.54.04 JACKSON (OS)- No, that' standard procedure.

25.57.09 KE'RA- If you say so.

25.58.10 JACKSON- I do. Say so. So. I'll come visit you in a little while, okay?

26.07.23 KE'RA- Is...

KE'RA (OS CONT)- Doctor Frasier still...

26.11.06 JACKSON- Yes.

JACKSON (OS CONT)- Yes, she is.

26.14.10 KE'RA- So I can rest assured?

26.16.12 JACKSON- Yes.

26.30.27 O'NEILL- Oh my. There is a distinct lack of optimism in this room.

26.36.18 FRASIER- We've been working around the clock trying to dissolve a chemical inside the brain without harming the surrounding tissue and...it is not easy.

26.43.10 HAMMOND- What have you learned?

26.45.09 CARTER- That it could take years, sir.

26.47.23 HAMMOND- Suffice it to say, we don't have that much time.

26.50.03 FRASIER- Un...less we get help.

26.53.15 O'NEILL- From?

26.56.07 CARTER- Ke'ra, sir.

27.00.24 HAMMOND- Absolutely not.

27.02.01 FRASIER (OS)- Sir.

FRASIER (CONT)- I don't like the idea any more than you. But without her latent...

FRASIER (OS CONT)- knowledge of biochemistry, especially of the residual Dargol, I don't know if we can...

FRASIER (CONT)-reverse the process of the amnesia in time to prevent a catastrophe on Vyus.

- 27.14.09 HAMMOND- Doctor. You're asking me to allow a known homicidal maniac to work with potentially lethal...
HAMMOND (OS CONT)- substances.
- 27.20.12 FRASIER- Yes, sir. But with all due respect, Daniel may be right.
FRASIER (OS CONT)- Ke'ra may be an entirely different person...
KE'RA (CONT)- than Linea. Without the memories that made her the person she was.
- 27.29.27 O'NEILL- Excuse me. Amnesia check. "Destroyer of Worlds?"
- 27.38.10 CARTER (OS)- Sir.
CARTER (CONT)- Ke'ra wants nothing more than to help her people. Now as long as she doesn't take the antidote that she comes up with...
- 27.43.24 FRASIER- But there won't be an antidote without her help, so...
- 27.46.00 CARTER- So...it's up to you. Sirs.
- 27.54.03 O'NEILL- I think a precaution or two might be in order, sir.

- 28.15.18 JACKSON- It's all right.

- 28.17.24 KE'RA- What have I done, Daniel?
- 28.19.10 JACKSON- Nothing. They're just going to escort us to the medical lab. I'll be with you the whole time. Doctor Frasier needs your help.
- 28.36.14 FRASIER- Now be...be careful, Ke'ra. That could become unstable or even explosive.
- 28.40.22 KE'RA- An unbalanced mixture could create a deadly, poisonous gas. We must not exceed three percent solution.
- 28.47.16 FRASIER- Okay,
FRASIER (OS CONT)- Three percent.
- 28.51.20 CARTER- She's brilliant.
- 28.53.26 JACKSON- Yes, she is.
- 25.55.15 CARTER- She's so far ahead of us, Daniel, it's frightening.
- 29.00.07 KE'RA (OS)- There is some danger. I would prefer to test it on myself.
- 29.03.05 FRASIER (OS)- That's not an option.

29.04.16 KE'RA (OS)- May I ask why?

29.05.27 FRASIER- Well, because if it's unsuccessful, we'll need your help to try again.

29.09.25 KE'RA- If it's unsuccessful, Orner may die. I would never forgive myself.

29.56.15 ORNER- (convulses; gasps)

30.07.13 FRASIER (OS)- Not breathing. There's no...

FRASIER (CONT)- pulse. It's a Code Blue!

FRASIER (OS CONT)- One two three four five six. Come on! Wait a minute—he's

stabilizing.

FRASIER (CONT)- Help me get him up.

FRASIER (OS CONT)- There.

30.46.21 ORNER- Ke'ra.

30.49.02 KE'RA- Do you remember?

30.53.23 ORNER- I am sorry.

30.56.12 KE'RA- Next time it will work.

KE'RA (OS CONT)- I believe I know where I miscalculated.

KE'RA (CONT)- May we begin again?

31.02.15 FRASIER- Why don't we wait and see how Orner feels in a little while?

31.05.04 KE'RA- The effect would have been immediate.

KE'RA (OS CONT)- It did not work. We must try again.

31.08.05 JACKSON- Doctor Frasier's right. We should probably take a break.

31.12.22 KE'RA- As you wish. Daniel. May we be allowed to speak alone?

31.38.06 JACKSON- Yes. I'm just gonna stay...

JACKSON (OS CONT)- for a minute.

31.41.29 TEAL'C- I will accompany you.

31.43.16 JACKSON-Teal'C.

31.46.26 TEAL'C- I am concerned only for your welfare, Daniel Jackson.

- 32.27.22 JACKSON- The Vorlix made the population of Vyus younger. Years younger.
JACKSON (OS CONT)- You couldn't find the elders because...
JACKSON (CONT)- you were the elders.
- 32.39.23 KE'RA- How can you believe that?
- 32.43.07 JACKSON- There is a test. It compares what we call DNA. It proves that you and
Linea are the same person.
- 32.49.18 KE'RA- Well the test is wrong. I'm not Linea.
- 32.53.04 JACKSON- No, you're not. You're Ke'ra now. Ke'ra's wonderful. And as long as you
remain that person, that will never change.
- 33.10.11 KE'RA- You're telling me that I will never be able to take the antidote. I would never
harm anyone, Daniel. Do you believe me?

- 33.45.20 O'NEILL- Hey. Heard the test didn't go too well.

CARTER (CONT)-- right.
- 34.57.09 KE'RA- I believe this potency will provide our antidote.

KE'RA (OS CONT)- They will explain.
KE'RA (CONT)- What will be done with me?
- 37.48.13 JACKSON- Well, if you don't take the antidote, I see no reason why you can't go back
to Vyus. I intend to ask them.

- 37.58.14 JACKSON- For all that you've done for them, they'll be grateful.

39.11.21 JACKSON- You'll have to kill me too, because I'm staying.

- 39.19.00 FRASIER- All right, Layale, you're next. Colonel, a vial and ampule are missing.
- 39.37.10 KE'RA- I deserve to die.
- 39.40.28 JACKSON- I don't believe that.
- 39.42.03 KE'RA- You don't understand. There's a part of me that cares for you, Daniel. More
than I've cared for anyone I've ever known. But there's this other part of me that
would gladly watch you die!
- 39.58.12 O'NEILL- Step aside, Daniel.
- 39.59.14 JACKSON- Don't!
JACKSON (OS CONT)- There's another way, Jack.
- 40.01.07 O'NEILL- Move!

- 40.04.05 KE'RA- There are two people inside of me. And one of them is a monster. In time,

41.06.00 KE'RA- Nothing.

41.08.08 JACKSON- Your name is Ke'ra.

JACKSON (OS CONT)- You've been a visitor here.

JACKSON (CONT)- Now it's time to go home.

41.27.28 MAYRIS (OS)-- She did this willingly?

41.29.16 CARTER (OS)- Yes. With her help, we...

CARTER (CONT)- were able to synthesize a small amount of the enhanced Dargol
that could cause the Vorlix and re-introduce it into her bloodstream. Her
