succeeded if it wasn't for your interference.

scientists was assigned to study them. The Pentagon was hoping to be  
able to adapt the devices for use in the field.

created by the aliens...

01:18:18:24 JONAS (CONT'D): seemed to last indefinitely, those that were created by the  
scientists in the lab were only sustainable for three to four minutes at a  
time due to problems with electromagnetic interference...

team members were reassigned.

01:18:31:25 JONAS (CONT'D): The remaining three were Dr. Singh, Dr. Healey, and this  
fellow...Dr. Brent Langham.
