   rules of evidence, he would be convicted of this crime.

01:21:54:19 MITCHELL: Yeah.

01:22:19:05 MITCHELL (V/O): It was the first time I saw him after the crash.

01:22:22:29 MITCHELL (CONT'D): Scared the hell out of me to see him like that.

01:22:26:20 MITCHELL (CONT'D O/S): Somehow he made it seem that everything was going to be okay.
